Event Dates

- June 6th—June 20, 2009 at locations across the United States and Canada

Format

- 200-point Constructed Assault format, according to the most current edition of the Dungeons and Dragon[®] Miniatures Game Battle Rules.
- *Treasure Trove* item stat cards and miniatures with released stat cards are legal.

Tournament Length

- Swiss rounds – Maximum length of 60 minutes per round, number of rounds based on attendance
- All players may participate in all Swiss rounds.
- Top 4 players enter a single-elimination playoff bracket.

Tournament Logistics

- 16K, Competitive REL
- All DCI Universal Tournament Rules and DDM Guild Dungeons & Dragons[®] Miniatures Tournament Competitive Floor Rules & Penalty Guide rules are in effect for this event.
